Moved in and rigged up rotary tools. Spudded 12-1/2" hole at 6:15 p.m. 9/8/79. Drilled to 1406'. Pulled out of hole and ran 33 jts. 8-5/8" 24# K-55 Casing. Set at 1406' and cemented with 425 sacks Halliburton-Lit w/1/4# Flocele and 8# salt per sack. Followed with 200 sacks Class C 2% CaCl. Plug down at 10:15 a.m. 9/10/79. Circulated 86 sacks. WOC-18 hours. Tested Casing to 1200 psi. Held ok. Reduced hole size to 7-7/8" and resumed drilling operations.
