2. Run Free Point Indicator and cut 4 1/2" casing. Estimated recovery $\pm$ 3300'. POH w/4 1/2" casing.
3. Spot 25 sx Class C Cement at top of 4 1/2" stub - 50' inside stub and 50' above stub.
4. Spot 35 sx (100') inside 8 5/8" casing from 1850-1750.
5. Spot 10 sx Class C Cement at surface.
6. Cut off casing head. Install marker.
7. Clean and level location.
