Halliburton-Lite-Weight, 10# Salt & 1/4# Flocele, followed with 200 sx. Class C, 2% CaCl. PD at 3:45 AM 3/28/81. Circ. 85 Sacks. WOC 18 hrs. Tested casing to 1,000 Psi. Held Ok. Reduced hole size to 7 7/8" and drilled to 4350' TD. Ran 104 Jts. 4 1/2: 10.5# casing set at 4350' and cemented with 325 sacks Class C, 50-50 Poz-Mix, 2% Gel and 4/10 of 1% CFR-2. PD at 10:30 AM 4/2/81. WOCU.
