Pride Energy Company proposes to move the heater-treater from the Grynberg Federal #4 well, located in the S $\frac{1}{2}$  NW $\frac{1}{4}$  of Sec. 11-8S-31E (BLM Lease # NM-11329), to the tank battery of the Curry and Thornton Federal #1 well, located in the NW $\frac{1}{4}$  SW $\frac{1}{4}$  of Sec. 11-8S-31E (BLM Lease # NM 56244).

There are currently 2 production tanks on the Curry and Thornton Federal #1 battery. One tank will be used for the oil from the Curry and Thornton Federal #1 well and the other will be used for the Grynberg Federal #4 well. The tanks will be marked with the well name and lease number. By doing this procedure, it should release the pressure from having to pump the oil up a steep incline and should increase oil production.
