Set at 1483' and cemented with 400 sacks, H-L-W, 10# Salt, 1/4# Flocele followed with 200 sacks Class C, 2% CaCl. Circulated 50 sacks. PD at 12:00 Midnite 4/12/81. WOC 18 hrs. Tested casing to 1200 psi. Held ok. Reduced hole size to 7 7/8" and resumed drilling. Drilled to 4,000' TD. Circ. & Cond. hole. POOH and RU casing crew, ran 95 jts. 4 1/2" 10.5# casing. Set at 4,000' and cemented with 325 sacks Class C, 50-50 Poz-Mix, 2% Gel and 4/10 of 1% CFR-2. PD at 6:45PM 4/18/81. Released rig at 7:45 PM 4/18/81. WOC and Waiting on completion.
