Spudded a 9-7/8" hole at 12:00 midnight 11-20-81. Lost 7 joints of 7" 20# 1005 casing set at 1638'. 1-Texas Pac. cement pump set at 1650'. Insert joint at 1650'. Cemented w/125 sacks Pacemaker 1, 1 Gal/G, 1/2 lb. of 40# cement, 500 sacks 50/50 Poz, .6% CF-9, .3% RI-4 and 3% KCL. Mixed in w/100 sacks of cement at 17' Gal/G. Compressive strength of cement - 1875 psi in 12 hours. Plugged at 12:00 noon 11-20-81. Pumped plug to 1250 psi, released pressure and flow is 1000 psi. Cement circulated 10 sacks. WOC. Drilled out at 6:00 AM 12-8-81. Lost 15 sacks of cement up and lost 1000 psi, okay. Reduced hole to 6-1/2". Drilled plug and resumed drilling.
