DETAILS OF WORK

Subject well was plugged and abandoned as follows:

1. Spot 35 sx at total depth.
2. Cut off 5 1/2" casing at 9500', and recover same.
3. Spot 35 sx from 50' below to 50' above top of non recoverable 5 1/2" OD casing.
4. Spot 40 sx. cement 9700' to 9800'.
5. Spot 40 sx. cement 7700' to 7800'.
6. Spot 40 sx. cement 5600' to 5700'.
7. Spot 40 sx. cement 4200' to 4300'.
8. Spot 40 sx. cement over the intermediate casing shoe 2825' to
9. Spot 20 sx. surface plug, install 4" marker extending 4' above ground. Clean location as per U. S. G. S. regulations, plug and abandon. Complete 10:00 AM June 13, 1961.
