TD 4006'. Ran 95 jts 4-1/2" 9.5# J-55 casing set 4006'. 1-regular guide shoe set 4006'. Insert float set 3966'. Cemented w/300 sx Class "C" + 1/4#/sack celloseal, 5% CF-1 and 2% KCL. Compressive strength of cement - 950 psi in 12 hrs. PD 6:00 AM 4-7-85. Bumped plug to 1000 psi, released pressure, float and casing held okay. Tested casing to 1000 psi for 30 minutes. WOC 18 hrs. WIH and perforated in 2 stages. Perforated 3770-3814' w/10 .34" holes as follows: 3770, 78, 81, 86, 92, 3802, 06, 08, 10 and 14'. Acidized perfs 3770-3814' w/2000 gals 20% NEFE acid and 2% KCL. Perforated 2nd stage 3768-3815' w/16 .34" holes as follows: 3768, 71½, 74, 79, 82, 87, 91, 93, 3801, 03, 05, 07, 09, 11, 13 and 15'. Frac'd perfs 3768-3815' (26 holes) w/1500 gals 20% NEFE acid, 40000 gals gelled KCL and 64200# (21200# 20/40 + 43000# 12/20) sand.
