8-23-89. RUPU & install BOP. Pumped dn csg w/100 bbls wtr. No returns on 8-5/8"x5 1/2" annulus. WIH w/bit to 4874' & set down. Pulled bit.

8-24-89. WIH w/pkr & set @4742'. Loaded annulus & tested to 1000#, OK. Loaded & pumped dn tbg 750# @4BPM. Obtained approval from Jerry Sexton, NMOC, Hobbs, to plug lower portion of well and recompleat in San Andres. Pumped 200 sx Cl C+.4% fluid loss additive dn tbg & displaced cmt past pkr w/23 1/2 bbls (to 6000'). Pump in pressure 1000#. Tubing-csg annulus held OK. No returns on 8-5/8"x5 1/2" casing annulus. SION.

8-25-89. Loaded tbg w/1/2 bbl. Pressured to 500#, held OK. Pull pkr & TIH w/tbg open-ended. Spot plug from 4871-4771'. WOC & tag plug @4730'. Perforate 4675 & 4725' w/4 shots. Could not pump in perfs at 3500#. SD due to muddy roads.

9-6-89. Ran CBL. Showed bridge 4550-4600'. Perforated San Andres P<sub>2</sub> 4570-76' w/12 .42" holes (2 SPF). 8-5/8"-5 1/2" annulus holding.

9-8-89. TIH w/pkr & tbg dry. Dropped bar & knocked out pkr disc. WIH swab. Found 200' water entry. 8-5/8"x5 1/2" annulus - no change. (continued page 2)

9-9-89. Set CIBP @ 4565' & perforate 4536-40' w/8 - .42" holes (2 SPF). Broke circulation between 8-5/8"-51/2" annulus. Set retainer at 4525'. Cemented w/300 sx C1 C w/1000 gals mud flush ahead. WOC.

9-11-89. Perforate San Andres P<sub>1</sub> w/16 .42" holes as follows: 4481, 82, 85, 87, 88, 89, 90, 92, 93, 96, 98, 99, 4500, 01, 08, and 4509'. TIH w/pkr and acidize w/2000 gals 20% NEFE. Testing well.
