We would like to simply change our two original staked locations for the Chaveroo Federal #2 (1930' F^NL & 1980' FWL, Sec. 15, T8S, R33E) and the Chaveroo Federal #3 (660' F^NL & 660' FWL, Sec. 15, T8S, R33E) around. Meaning, we would like to call the original staked location #2, now the #3, and the originally staked location #3, now the #2. Both wells still having the same footage, etc.

So it should read now: the Chaveroo Federal #3 (1980' F^NL & 1980' FWL Sec. 15, T8S, R33E), the Chaveroo Federal #2 (660' F^NL & 660' FWL, Sec. 15, T8S, R33E) and will be drilling the #2 in July.
