DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Total depth 276' in Red Bed. Ran 16 joints of 8 5/8" casing, 274.80' set at 276' and cemented with 150 sacks. Plug down at 11:00 P. M. August 3, 1947. Cement was allowed to set 24 hours, plug drilled out and hole bailed dry. No water came in, in one hour. Picked up drill pipe and drilling was resumed.
