DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Total depth 286' in red bed. Ran 278' of 8 5/8" OD 25.55# Lap Weld Line Pipe set at 285' and cemented with 150 sacks. Plug down at 5:00 P. M. January 19, 1948. Cement was allowed to set 24 hours, plug drilled out and hole bailed dry. No water came in, in one hour. Picked up drill pipe and drilling was resumed.
