On 6-16-70 a 25 sack cement plug was set at 3008'. Pulled 40 joints of tubing and shut well in overnight, plug held OK. Loaded hole with mud, shot and pulled 812' of 5-1/2" casing. Set 25 sack cement plugs at 812' and 292'. Set 10 sack plug and marker at the surface. Plugging operations completed 6-19-70.
