Detailed account of work done, nature and quantity of materials used and results obtained.

On October 7, 1957, at a total depth of 3097' we ran 98 lbs. 9.50" J-55 4 1/2" casing, 3098.72', landed @ 3096.50' and cemented with 125 sac, 50-50 pozmix with 2% gel added preceded by 20 bbls. of lime water. Plug down @ 6:35 P. M. 10-7-57. Pipe was rotated to bottom and during cementing. After allowing the cement to set 48 hours, the casing was tested to 1000' and pressure held for 30 minutes with no drop recorded. The plug was not drilled. A combination guide and float shoe was used and 3 centralizers were used, 1 @ 3093' and 1 @ 3061' and 1 @ 3030'. Halliburton did the cementing.
