Ran 3912' of 9-5/8" 36# Seamless J-55 casing and set at 3925'. Cemented with 1648 sacks 3% Gel, 412 sacks Signalite and 200 sacks Neat. Circulated 300 sacks. Pipe and casing seat tested with 1200 psi for 30 minutes before and after the drilling out of the cement on March 30, 1953. Both held O.K.
