DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 241 joints 9736' of 7" OD 8 RT 29,26,23# N-80 & J-55 SS casing. Set & cemented at 9750' w/210 sacks regular neat Longhorn portland cement. Plug at 9660'. Maximum pressure 800#. Gulf temperature survey in 10 hours found top cement at 8995'.

After waiting over 30 hours tested 7" casing w/1000# pressure for 30 min. There was no drop in pressure. Drilled cement plug and cleaned out to 9850.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to complete well.
