Worked stuck packer with no results. Cut 2-3/8" O tubing at 8800'. Spotted
35' (5 sx.) cement plug on top of 2-3/8" tubing. Displaced hole with mud.
Cut 5-1/2" OD casing at 6805' and attempted to circulate with no results.
Perforated 5-1/2" casing at 4900' and 4200' and attempted to circulate with
no results. Cut 5-1/2" casing at 4800', 4400' and 4270'. Pulled 5-1/2" casing
from 4270'. Spotted 100' (37 sx.) cement plug at 6900'; 100' (50 sx.) cement
plug at 5100'; 100' (50 sx.) cement plug at 4270' and 100' (70 sx.) cement
plug at 1700'. Cut and pulled 8-5/8" casing from 670'. Spotted 100' (70 sx.) cement
plug at 300'. Spotted 10 sx. cement plug at surface. Installed permanent dry
hole marker.
