**11,046' - Total Depth - Line, 9460' Plugged Back Depth. Ran Temperature Survey - Top of cement on outside of 5-1/2" casing 6325'. W.O.C. 48 hours. Connected 5-1/2" casing, ran 4-3/4" bit & 2-3/8" O.D. BUE Tubing and tested 5-1/2" casing & well connections with 1100# for 1/2 hour - no pressure drop. Drilled cement to 9415', circulated hole clean & tested with 1100# for 1/2 hour - no pressure drop. Continued drilling operations.**
