3820' - Total Depth - Lime. Ram Temperature Survey, found top of cement outside 8-5/8" casing at 640'. Ratio of actual to calculated fill, 65.5%. Checked top of cement inside 8-5/8" casing at 3753'. Tested casing with 1100# for 1/2 hour - no pressure drop. Drilled cement from 3753' to 3818' and tested casing with 1100# for 1/2 hour - no pressure drop. Started drilling 7-7/8" hole at 12:00 Noon, 2/3/52.
