DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

TD 4050, set 8 5/8" OD casing @ 4048 and cemented with 1600 sacks of cement. Ran temperature survey and found top of cement back of 8 5/8" casing @ 1620' from surface. Let cement set 48 hours and tested with 1,000# pump pressure for one hour before and after drilling plug. No decrease in pressure. Resumed drilling.
