TD - 4045 - Set 8 5/8" OD casing @ 4044 and cemented with 1600 sacks of cement. Ran temperature survey which indicated top of cement behind 8 5/8" OD casing at 790 from surface. - Let cement set 48 hours and tested with 1100# pump pressure for 30 minutes before and after drilling cement plug. No decrease in pressure. Resumed drilling.
