TD 4085 - set 8 5/8" OD casing @ 4084 and cemented with 1700 sacks cement. Ran temperature survey which indicated top of cement back of 8 5/8" OD casing @ 785' from surface. Let cement set 48 hours and tested with 1,000# pump pressure for thirty minutes before and after drilling plug. No decrease in pressure. Resumed drilling.
