TD 4065, set & 5/8" OD casing @ 4058 and cemented with 1700 sacks cement. Ran temperature survey which indicated top of cement back of 8 5/8" casing @ 890' from surface. Let cement set 48 hours and tested with 1,000# pump pressure for 1 hour before and after drilling cement plug. No decrease in pressure. Resumed drilling.
