We propose to round trip the tubing and spot a 75 sack cement plug to cover the perforations from 9603-9678; to pull all possible 5 $\frac{1}{2}$ casing and spot a 50 sack plug in the bottom of the 8-5/8 casing, a 25 sack plug in the 8-5/8 or the top of the salt, a 50 sack plug at the bottom of the surface and a 5 sack plug at the top with a 4" marker 5' above the ground.
