FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

We propose to round trip tubing and place a 75 sx bottom hole plug to cover exposed perforations above present bridge plug. A 50 sx cement plug will be placed in the top bottom of the 8-5/8" casing, a 25 sx cement plug will be placed in the stub of the 8-5/8 or in the top of the salt, a 50 sx cement plug at the bottom of the surface and a 5 sx cement plug in the top with a 4" marker 5' above the ground.
