To increase production, we propose to do the following work:

1. Perforate 5 $\frac{1}{2}$ " casing from 9757--9759', 9766--9768', 9774--9778', 9930--9936' with two jets per foot.
2. Run retrievable bridge plug and hookwall packer and acidize zones as follows: 9757--9778' with 2000 gallons regular 15% acid, 9858--9884' with 2000 gallons regular 15% acid, 9930--9936' with 1000 gallons regular 15% acid.
3. Swab, test, and return to production.
