FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Load hole with mud.
2. Shoot off and pull 5 1/2" casing from 8800'.
3. Spot cement plugs as follows:

20 sxs. at 8300'	20 sxs. at 4800'
20 sxs. at 8050'	25 sxs. at 4179 (Bottom of 8-5/8" pipe)
20 sxs. at 7100'	10 sxs. at surface
20 sxs. at 5400'	

At the present time, all perforations are squeezed off and there is a cement plug extending up the hole to 9604'.
