305' T.D. - Red Bed. Finished drilling 17-1/2" hole @ 11:00PM, 11-28-53. Ran a total 7 jts. of 13-3/8" OD Casing set @ 296' w/ 250 sz. cement. Pumped plug to 281' @ 2:30AM w/ max. pump pressure of 200#. Cement circulated. After WOC for 12 hours, tested casing w/ 500# for 1/2 hour - no pressure drop. Drilled cement from 281' to 305' and tested casing for 1/2 hour w/ 500# - no pressure drop. Started drilling formation and 12 1/2" hole @ 5:30PM, 11-29-53.
