305' - Total Depth. Red Bed. Finished drilling 17-1/2" hole @ 2:30 AM, 11/19/52. Ran a total of 7 Jts of 13-3/8" OD 36# Armco S.W.-S.J. Casing set @ 296' with 250 sx cement. Pumped plug to 289' at 9:35 AM, 11/19/52. Max. Press. 200#. Cement circulated. After WOC for 12 hours, tested casing for 1/2 hour W/200# - no pressure drop. Drilled cement from 281' to 305' and tested casing for 1 1/2 hour W/200# - no pressure drop. Started drilling formation and 12-1/4" hole @ 1 PM, 11/20/52.
