FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Drilled to T.D. 13,563', 13-3/8" OD casing set at 314' and cemented to surface, 9-5/8" OD casing set at 4421' and cemented to surface. No oil or gas in commercial quantities was encountered in any zone. We propose to plug to abandon as follows:

100 sacks cement - Spotted on bottom at 13,563'
75 sacks cement - 10,400-10,600'
75 sacks cement - 9,800-10,000'
75 sacks cement - 7,400-7,550'
75 sacks cement - 5,050-5,250'
75 sacks cement - 4,450-4,325'
10 sacks cement - Surface Cap

All other intervals from surface to total depth will be filled with heavy mud laden fluid.
