FBTD 9593, Wolfcamp, perforated 5 1/2" OD casing W/4 jet shots per foot from 9580 to 9590. Swabbed dry, acidized W/500 gallons of mud acid @ 3200# @ 3/10 barrels per minute. Completed @ 159 barrels oil in 24 hours.
