Cement Plugback has been set from 9445' to approx. 8940' w/50 sk. slow set cement.
Will attempt to recover 6500' of 5 1/2" casing and will place 25 sk. cement plug in stem.
Will set 25 sk. cement plug from 5915' to approx. 5865'.
Will set 25 sk. cement plug from 4520' to approx. 4470' (Base 9 5/8" casing).
Will attempt to recover 2000' of 9 5/8" casing and will set 25 sk. cement plug in stem.
Will place 25 sk. cement plug in bottom and 10 sk. cement plug in top of 13 3/8" Surface
Pipe and erect Monument.
Gel mud will be left in hole between all cement plugs that are set.
