FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

Subject well was drilled to a TD of 12,111. Top of Devonian was encountered at 12,050 (Sample Top). DST's of the Section indicated the Devonian Section to be water bearing.

Our intentions are to, (1) Place a 50 sack Cement (Neat) Plug over the interval from 12,111 to approximately 11,980; (2) Run 7" casing to approximately 10,400 and cement with 275 sacks of 8% gel cement followed by 100 Sx Neat Cement; (3) Pennsylvanian Section will be tested through perforations; (4) If the Pennsylvanian proves commercially non-productive, the Wolfcamp Section will be tested in the same manner.
