In order to shut off water and increase production we propose the following:

Set drillable retainer at approximately 11,880', squeeze perforations 11,900' - 11,940' with 150 sacks also set cement and leave a 10' cap above retainer. Run Correlation log from 9000' to 11,870' and perforate 11,835' - 11,860' with 4 shots per foot. Acidize perforations with 2,000 gallons 15% regular acid and flush with 50 barrels oil, test well and return to production.
