DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On April 4, 1953 at 3:30 A.M., 32 hours had elapsed since running 301' of new 13-3/8" casing landed at 321' and cemented with 255 sacks mixed 8% gel plus 100 sacks neat cement, circulated to surface.

Casing shut-off was tested with 450 psi for 30 minutes before and after drilling plug. Since there was no appreciable drop in pressure on either test, drilling operations were resumed.

Well was spudded April 1, 1953.
