DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On September 16, 1953 ran 9808' of 7" casing landed at 9818 and cemented with 150 sacks cement mixed 4% gel and 150 cubic feet perlite. After 36 hours W. O. C. tested 7" casing with 1000 psi for 30 minutes with no drop in pressure. Drilled firm cement to 9770' and tested casing for 30 minutes, and as there was no drop in pressure completion operations were resumed.
