4600'-4495' 40 sack cement plug
4495'-25' filled with 10#/gal. mud
25'-0' 10 sack cement plug

Cement plugs were placed with drill pipe by displacement.
A pipe 4" OD, extending 4' above ground level, was cemented
in top of 9 5/8" casing.
No attempt was made to recover casing from this well.
