On June 14, 1951, ran 141 joints, 4652', of 9 5/8" OD 8 R. T. new SS casing. From bottom up, 29 joints 40# N-80 R-3 with LT&C, 111 joints 36# J-55 R-2 with ST&C, one joint 40# N-80 R-3 with LT&C, with 3 B&W 9 5/8" casing centralizers at 4663', 4623' and 4583'. Set and cemented at 4668' with 2,000 sacks 2% gel. bulk cement. Plug at 4632'. Cement circulated. Job complete at 5:45 p.m., June 14, 1951.

Propose to drill plug and test shut-off at 5:45 p.m. June 16, 1951.
