This well was temporarily abandoned in November 1963 and held for future salt water disposal service. It now appears that it will not be needed, therefore we propose to plug and abandon. A 25 sack cement plug will be spotted at 9300' just above the perforations. The 5-1/2" casing will be cut and pulled from 6000' and a 25 sack plug placed in top of the stub. A 25 sack plug will be put in the bottom of intermediate casing at 4627', and 10 sacks placed at the surface. The location will be marked with a permanent steel marker.
