FULL DETAILS OF PROPOSED PLAN OF WORK  
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Perforate Devonian section 12,487'-12,495' with 4 holes per foot, treat with 500 gallons of acid. If non-productive, set a cast iron bridge plug at 12,250'.
2. Perforate Permo-Penn section 10,256'-10,271' with 4 holes per foot, treat with 5,000 gallons acid. Set cast iron bridge plug at 10,200'.
3. Perforate Upper Wolfcamp section 9381'-9399' and 9239'-9313' with 4 holes per foot, treat with 5,000 gallons acid. Well to be placed on production from Upper Wolfcamp section.
