On June 8 & 9, 1948 ran 224 jts new 7" OD 23# 8 Rd Thd N-80 & J-55 Range 2 & 3 SS csg w/long T&C and one 7" Weatherford csg centralizer spaced @ 7330' (From bottom up: 22 jts N-80 Range 3 csg, 33 jts N-80 Range 2 csg and 169 jts J-55 Range 2). Tallies 7477.55' H-12.45', set @ 7490'. Cemented w/675 sacks of 2% and 125 sacks neat bulk cement. Plug @ 7444'. Job started @ 6 PM June 8, and completed @ 7 AM June 9.

Propose to drill plug and test shut-off @ 7 AM, June 11, 1948.
