Detailed account of work done, nature and quantity of materials used and results obtained.

This well was drilled to 4485' in lime. Ran 117.9 jts. (4469.31) of 8 5/8" OD 32# J-55 and H-40 8rd thd. casing set at 4484.51 and cemented with 1042 sacks cement being 476 sacks incor neat mixed with 357 sacks Diacel D (40%) and 9 sacks calcium chloride (2%) and followed with 200 sacks neat on bottom. Cement circulated. Plug was down at 11:45 AM September 7, 1957. Cement was allowed to set 48 hours prior to testing for shut-off. Prior to drilling plug, 1200 pounds pressure was applied with all valves closed during a 30 minute interval with no drop in pressure. After drilling plug, 1500 pounds pressure was applied with all valves closed during a 30 minute interval with no drop in pressure. Drilling resumed.
