Shot casing @ 4000 feet. Recovered 2058 feet of 5 1/2" 17# Speedtite and 1927 feet of 5 1/2" 17# LTC casing. Ran tubing and spotted 100' cement plug from 4050' to 3950' with 6 sacks cement in 5 1/2" and 19 sacks cement in 9 5/8" casing. Spotted 50' cement plug 50 feet to surface with 19 sacks cement. Remaining hole loaded with gelled mud. Put well head nupher in well. Complete Plug & Abandon at 4:00 P.M., July 25, 1963. Location leveled and cleaned.
