2. Parted 5 1/2" casing @ 4938' and pulled free casing.
3. Placed 35 sack cement @ 4938'.
4. Placed 25 sack cement @ 4600'.
5. Placed 20 sack cement @ Surface.
6. Cut off Bradenhead and welded on plate w/ suitable marker.

Unable to recover pipe below 4938'; therefore, additional plugs @ 5886', 7148', and 7816' requested on approved Form C-102 could not be placed.
