8-30-61 - Cemented 72' of 4-1/2" OD 12.6" Extreme Line Casing from 11887 to 11959 w/25 sks cement & 25 gals laytex. Reversed out 6 sks. Completed 5:30 PM 8-30-61. WOC.

9-3-61 - Jet perforated 4-1/2" liner in Devonian Zone w/6 holes on 1 plane at 11930'.

9-4-61 - Ran 2" tbg to 11945' w/packer set at 11751'.

9-5-61 - Ran rods & pump & placed well on pump - testing.

9-7-61 - On potential test ending 6:00 PM 9-7-61, well pumped 270 bbls new 47.0 gravity oil & 27 bbls formation water in 18 hrs, for a 24 hr calculated potential of 360 bbls oil per day. OGR 680 to 1.


