DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On May 17, 1953, acidized w/8000 gallons 15% NE acid thru perforations in 7" casing from 9495-9493' by Cardinal Chemical Company. TP 2900# CP 2100#. Flushed with 40 bbls oil.

RESULTS: Swabbed 40 bbls oil and 76 bbls acid water in 7 hours. Swabbed 164 bbls oil and 128 bbls water in 24 hours. Well kicked off and flowed 71 bbls oil and 37 bbls water in 8 hours.
