DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 11 joints 353' of 13-3/8" OD 8 RT 48# H-40 SS Casing. Set and cemented at 369' w/450 sacks Longhorn Regular Neat cement. Plug at 349'. Maximum pressure 300#. Cement circulated.

After waiting over 24 hours tested 13-3/8" casing w/500# pressure for 30 min. There was no drop in pressure. Drilled plug from 349' to 369', tested cement below casing shoe w/300# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
