Drilled out and tested casing, reran production equipment and resumed production from the Devonian Zone through casing perforations from 11,741' to 11,782'. Status of well changed from a dual completed oil well in the Mississippian and Devonian Zones to single completed well in the Devonian Zone, effective 4-16-68.

Instructions
