322' - Red Bed. Finished 17-1/2" hole to 322' at 2:15 p.m., 10-11-55. Ran 8 jts. 13-3/8" OD 36# Armo SW SJ Casing New, set at 318' with 350 sacks 50% Regular & 50% Pozmix Cement mixed 2% Jel & 50 sacks Iner Cement, total of 400 sacks. Plug down to 280' at 7:15 p.m., 10-11-55. Maximum Pump Pressure 400#. Cement circulated. After waiting on cement for 24 hours, drilled cement inside 13-3/8" casing from 280' to 318' & in open hole from 318' to 322'. Started drilling 12-1/4" hole at 322' at 7:30 p.m., 10-12-55.
