D.S.T. #2 was made from 9,595 feet to 9,612 feet (17'). Length of test 2:03 minutes. Results strong blow of air throughout test. Recovered 4,200 feet of gas in drill pipe. Recovered out 1,800 feet of oil and gas out drilling mud, and 600 feet of salty sulphur water. Recovered heavy circulating sub 450 feet of salty sulphur water, 132 minutes, I.S.I.P., 3,500#, 30 minutes, F.S.I.P., 2,372#, I.F.P., 426#, F.F.P., 1,042#. Hydrostatic pressure in and out of hole 4,546#.
